

## **Privacy Statement**

Ethiopiaid Ireland values your support and we are committed to protecting your privacy. We are sharing this statement with you so that you understand how we manage any information held about your support for and interest in our work.

### **Personal information**

The Ethiopiaid Ireland website is a safe platform for our supporters to visit and on which to make online donations. Ethiopiaid takes the necessary precautions to ensure any donations made online are secure. When you make a donation online we ask for your name, contact details, address, and credit card information.

The information we collect is used to process your donation(s) and to verify credit card data. We use your mailing address to send you an acknowledgement and unless you opt out, we will also use your postal address or email address (depending upon your preference) to keep you informed about how your donation is helping the most impoverished and marginalised in Ethiopia. You can opt out of further information by post or email at any time by calling us or emailing [hello@ethiopiaid.ie](mailto:hello@ethiopiaid.ie)

If you provide us with your telephone number, it will be used to contact you if we need to verify your donation(s) or for other types of administration calls. We will only use your telephone number to contact you regarding our fundraising appeals if you have given us permission to do so.

If you opt in to receive emails, then you are giving your consent to receive regular e-news and other updates. You can unsubscribe from our emails by clicking the link in our most recent email at any time.

We do not knowingly collect any personal information from a child without the consent of the child's parent(s). Children under the age of 16 should obtain parental consent before donating.

We may also receive information about you from third parties, for example from a friend who wants to make a donation in your name with a request that we send you information; or from service providers and reputable public data sources enabling us to create a profile of your interests, preferences and level of potential donations so that we can provide you with a better supporter experience.

### **Do we share your information?**

We will never sell, trade or rent your personal information to anyone.

We may disclose to third parties aggregate statistics regarding donations but these statistics do not include any personally identifying information.

All credit card donations are processed by a third-party financial institution who will only use your personal information for the purpose of processing the transaction.

We may also use third-party agencies to help us keep our data updated and make sure our fundraising communications are correctly managed and are as cost efficient as possible. This could include keeping address records correct by screening against public information relating to deceased files or address changes.

## **Cookies**

Our website uses cookies, small pieces of data stored inside a website browser, across our websites to improve their performance and to enhance your user experience. When you visit our websites, cookies allow us to collect some non-identifying basic information. This includes the total number of visitors, the pages viewed, and other anonymous information. We use this information to make your experience on our website as smooth as possible and to allow us to make any necessary improvements.

We do not use cookies to:

- Collect any personally identifiable information without your express permission
- Collect any sensitive information without your express permission
- Pass data to advertising/marketing networks
- Pass personally identifiable data to third parties

You are always free to decline our cookies. To do this, you can modify your web browser to refuse cookies, or to let you know when you receive new cookies.
